
NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 15 March 2018 Kibaran Resources Limited (“**Kibaran**” or the “**Company**”) (ASX: KNL) issued 150,000 fully paid ordinary shares in the capital of the Company (“Shares”) as consideration for services provided by a third party.
